## ABOUT THIS UNIT

**BUS201** is a 3 credit point unit.

This unit introduces students to the implications of differences in social processes and organisational structures, management practices and communications for international business decisions. It will also consider the implications of the sociological, economic, technological and political environments on decision-making practices. Included in the unit will be a review of differences in culture, ethics, work and family/lifestyle issues, work motivation and loyalty to the organisation.

## OBJECTIVES

This unit will provide the theoretical foundation for the BIB Degree. Subsequent 300-level BUS course units will allow further in-depth study of many of the topics introduced here. Group work will allow students to interact positively, and presentations will further the development of essential business communication skills.

### **RELATIONSHIP BETWEEN ASSESSMENT AND LEARNING OUTCOMES**

Knowledge and understanding of the subject matter is assessed using a mixture of presentation, group discussion, written submission, and multiple choice and short answer exam questions. The ability to work collaboratively and creatively to build a presentation of a group view is seen as a valid demonstration of commitment to mastering the subject matter. There are five assessment components: a group assignment, a personal mini assignment, an individual assignment, a mid-term exam and a final exam. Together the assessment tasks cover the unit. **Please Note: You must pass the final exam to pass the unit.**

#### **Group Assignment - 15%**

This is a group exercise – all members of the group are expected to contribute actively and substantially. While it is understood that some members of the group may provide more input in the research area whereas others may do more of the actual written work, the group will be required to acknowledge that all group members have given quality time to the project. Your group members will be allocated in class. The topics will be distributed in

class in Week 5 – your responses will be required by end of class in Week 10. Late submission of the Group Project will incur a penalty of 10% of the value of the assignment for every day that it is late.

**Mini Assignment** - **5%**

A mini assignment will be required in this unit. A 1,000 word response is expected. This assignment will be available on Blackboard in Week 2, and responses will be required in Week 5. No late submissions will be accepted.

**Individual Assignment** - **15%**

Each student will be expected to submit an individual assignment of 2,500 words on a topic to be provided. The topic will be available in Week 3; responses are required by end of class in Week 7. Late submission of the assignment will incur a penalty of 10% of the value of the assignment for every day that it is late.

**Mid-Term Examination** - **15%**

The mid-term exam will be a multiple choice format. It will be held in class in Week 8.

**Final Examination** - **50%**

The final exam will be held in the formal examination period. The examination will be “closed book”. It may contain a multiple choice section as well as a written section addressing the whole of the unit. Further details will be given later in the semester regarding format and content. You must pass the final exam to pass the unit.

**The University examination period in Semester 1 is from 11 to 27 June, 2008**

You are expected to present yourself for examination at the time and place designated in the University Examination Timetable. The timetable will be available in Draft form approximately eight weeks before the commencement of the examinations and in Final form approximately four weeks before the commencement of the examinations.

On occasion your raw mark for a unit (i.e., the total of your marks for each assessment item) may not be the same as the SNG which you receive. Under the Senate guidelines, results may be scaled to ensure that there is a degree of comparability across the university, so that units with the same past performances of their students should achieve similar results.

It is important that you realise that the policy does not require that a minimum number of examiners to explain their actions if more than 20% of students fail in a unit.

The process of scaling does not change the order of marks among students. A student who receives a higher raw mark than another will also receive a higher final scaled mark.
