ABOUT THIS UNIT

Unit description and rationale

This unit is to familiarise students with some important substantive topics in the field of demography. While emphasis will be placed on the study of Australian population, the demographic situation in selected other countries and regions will also be covered. The unit will appeal to students from a wide range of backgrounds with an interest in demography. Topics covered will help students establish a better understanding of the demographic issues in relation to other elements in business and society. The unit should also assist students in developing skills in note-taking, accessing demographic literature, essay writing, and critical thinking.

iLectures

DEM255 lectures will be recorded using the iLecture system. Whilst the iLectures may provide an additional resource, students are advised that no guarantees are given in relation to the availability or quality of the sound recordings or the functioning of any related websites or links to files of recordings of lecture. Students are expected to attend the lectures on a regular basis and to compile notes during the course of the lectures. Thus any failing of the iLectures will not be accepted as grounds for appeal.

LEARNING OUTCOMES

The main outcomes that students are expected to achieve from this unit include:

- knowledge of main sources of demographic data and literature;
- knowledge of major demographic issues;
- knowledge of major demographic changes in Australia and their implications;
- ability to use demographic concepts to interpret demographic transition and its contributory factors;
- ability to appreciate the importance of demographic elements in business decisions and social policy-making;
- ability to write a major essay on relevant demographic topics; and
- ability to use appropriate academic referencing style.

In addition to the discipline-based learning objectives, all academic programs at Macquarie seek to develop students' generic skills in a range of areas. One of the aims of this unit is that students develop their skills in the following:

- foundation skills of literacy and numeracy;
- information literacy skills;
- analytic skills; and
- critical thinking skills.

TEACHING AND LEARNING STRATEGY

The teaching strategy consists of the provision of information in the weekly lectures, a library information session, and a field trip to visit the Australian Bureau of Statistics. Copies of overhead slides for each topic will be provided via Online Learning @ MQ. It is recommended that students print a copy of the slides beforehand and bring them to the lecture. The iLecture on each topic will assist students' revision of each lecture at their own pace. It is expected that students will attend the weekly lectures and other activities on a regular basis and will actively take notes during the lectures.

In addition to the time spent attending lectures and other activities and doing assignments, each student is expected to spend a significant amount of time preparing for lectures, updating lecture notes, reading demographic literature, preparing for the assignments (short and major essays), and revising for the final examination (12 hours per week is recommended). There is no mid-semester exam for this unit. A major essay will be used to assess students' ability to use demographic data and literature to analyse one or more major demographic issues.

RELATIONSHIP BETWEEN ASSESSMENT AND LEARNING OUTCOMES

The requirements of this unit consist of regular attendance at lectures, participation in the field trip, and satisfactory completion of the assignments, major essay, and the final examination.

Assessment will be by three assignments (short essays), one major essay, and a final examination. The weighting given to the various assessment tasks will be:

- **Assignments (three in total)** (15%)
- **Major Essay** (20%)
- **Final Examination** (65%)

Please note that you must achieve a satisfactory performance both in the classwork (class attendance, assignments, and major essay) and in the final examination components of this unit.

Details of the dates of distribution of and for submission of assignments for DEM255 are given in the Schedule of Lectures. All assignments submitted should have a cover sheet which clearly states the student's ID number, the name and code of the unit, the number of the assignment, and date of submission. **All assignments should be submitted in class at the scheduled lecture time unless otherwise specified.** Penalties will be incurred for the late submission of assignments, unless satisfactory evidence of unavoidable disruption is presented. Teaching staff may refuse to mark the work of students who have a poor record of attendance or who have previously been late in submitting assignments (without satisfactory evidence of unavoidable disruption) on more than one occasion. **In addition, for each assignment, teaching staff may randomly select 10% of students to submit an electronic copy of their assignments for the purpose of detecting plagiarised contents in the assignments.**

This is a reading and writing intensive unit. The three assignments will be short essays -- either a critical review of one or more papers/chapters or a comprehensive analysis of demographic issue(s) covered in the lectures. Questions in the final exam will be in the format of short essay and short notes. The major essay assignment is expected to be approximately 20 pages in length with appropriate footnoting and referencing style.

Dictionaries are not allowed in the exam.

Students are advised that a poor record of attendance in lectures may adversely affect the grade awarded. Satisfactory attendance in lectures and other activities may be used to determine a marginal grade. A marginal performance in the final examination will normally result in a marginal final grade being given. Satisfactory attendance is 75% of lectures.

EXAMINATIONS

The University Examination period in the First Half Year 2008 is from 11 June to 27 June. You are expected to present yourself for examination at the time and place designated in the University Examination Timetable. The timetable will be available in Draft form approximately eight weeks

before the commencement of the examinations and in final form approximately four weeks before the commencement of the examinations at <http://www.timetables.mq.edu.au/exam/>.

The only exception to not sitting an examination at the designated time is because of documented illness or unavoidable disruption. In these circumstances you may wish to consider applying for Special Consideration.
